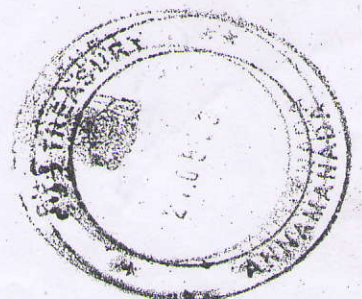

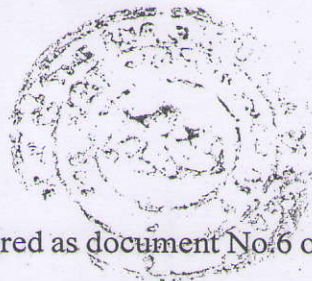

Chennamangalathukaran Eliabai Jew aged 50, Merchant Son of Aphraim of Vadama Village Mukundapuram Taluk Trustees of the Mala Synagogue on behalf of the Synagogue hereinafter referred to as the Donors in favour of Athappilly Joseph Christan aged 37 Son of Devassy, Vadama Village, Mukundapuram Taluk the President of the Mala Panchayath for and on behalf of the said Panchayath hereinafter referred to as the Donee.

Witnesseth whereas as per the Power of Attorney registered as document No:6 of Book II of 1950 of the Mala Registry Office read with by Document No:22 of Book II of 1954 at the same Registry Office the Donors have been authorised by the entire Jewish community of Mala and have become entitled to alienate all properties movable and immovable, appertaining to the Jewish Synagogue of Mala including the Synagogue Building and its premises. And whereas the Donee has agreed to accept and retain a gift of the properties in schedule A annexed here to and an entrustment of the item in schedule B subject to the conditions and obligations recited herein the Donors hereby voluntarily do make a gift and deliver possession of the schedule A item to the said Donee to be held by him subject to the following condition _____ 1. Avrony (Sd) 2. Eliacha (Sd) 3. Eliabai (Sd) 4. Joseph (Sd)

(1) The item in the A schedule should under no circumstance be used or converted as a place of Worship of any Denomination or Sect. (2) Under no circumstance should the A schedule item be used as a Slaughter house. (3) The Donee shall maintain the A schedule building in proper tenantable repair meeting all the charges for its annual maintenance and repair. (4) The Donee shall not in any manner alienate the A schedule item to any individual person or Corporation. (5) The Donee shall in a conspicuous part of the building in the A schedule announce and notify by a permanent and indelible inscription the factum of this gift so as to perpetuate the memory of the Mala Synagogue. (6) The Donee shall maintain at his own expense the Jewish Cemetery described in the B schedule hereto annexed and hereby entrusted to him and shall preserve the same without trespass or molestation of the tombs. Nor shall any portion of the cemetery be dug or unearthed. The compound wall bounding the cemetery on all sides and the gate in it shall also be preserved and the Donee shall meet the expenses if any necessary for its preservation in good repair.

The B schedule item shall not be alienated and shall ever be preserved in its present condition without being put to any other use. Nor shall the right of any member of the Jewish community to use the B schedule item as a cemetery be ever denied or questioned. 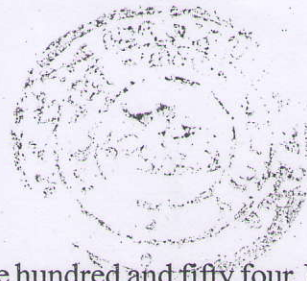
